Fair Work (Registered Organisations) Act 2009

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Union's rules prior to lodging nominations.

Nominations must reach the Returning Officer via the lodgement method(s) stipulated below **not later than** 12:00 pm (Noon) (local time of the returning officer) on 15/04/2019.

Withdrawing Nominations

Nominations cannot be withdrawn after 12:00 pm (Noon) (local time of the returning officer) on 15/04/2019.

Voting Period

The ballot, if required, will open on 03/06/2019 and close at 12:00 pm Noon (local time of the returning officer) on 01/07/2019.

Scrutineers

A candidate may appoint any financial member of the Division as a scrutineer in writing to the Returning Officer before the commencement of the ballot. A form is available from the Returning Officer for the purposes of appointing Scrutineers.
